2022 CATOCTIN & FREDERICK DISTRICT HIGHLIGHTS

- One local student earned top honors in the poster contest at the MASCD Summer Meeting. Hope Rice of Sabillasville Environmental School earned 1st place Maryland Association of Soil Conservation Districts poster in the 4th-6th grade division!
- Maryland Department of Agriculture's (MDA) Manure Injection and Transport programs provided \$250,598.48 in assistance to help district cooperators inject 1622 acres with manure and transport 4,560 tons of manure from fields with high phosphorus to fields were phosphorus was needed.
- The Maryland Agricultural Water Quality Cost-Share (MACS) Program provided \$459,495.00 in cost share assistance to cooperators in the Catoctin District to assist with the installation of various best management practices.
- Frederick County Farmers enrolled **27,706** acres in MDA's Cover Crop program which provided **\$1,247,193.00** in assistance to help offset the cost of purchasing seed and planting small grains that provide winter cover but are not harvested.
- Frederick County cooperators received nearly **\$2,698,266.09** in payments for completed contracts through NRCS programs including: **EQIP, AMA, RCPP, and CSP**.
- The USDA Farm Service Agency (FSA) distributed over **\$5,048,890.67** to Frederick County cooperators enrolled in programs such as **CFAP, CFAP2, CRP, MAL, DMC, WHIP, FSFL, ARC/PLC.**
- With both state and federal funds we installed 362 BMPs.
- Planners wrote conservation plans covering 10,376 acres.
- The Frederick District awarded the 2022 George A. Nicholson, Sr. Memorial Scholarships to: Abigail Beckman and Alana Baye.

Chris and Jamie Derr operate Valley-Ho Farm in Middletown, MD where they milk Holstein cattle, raise replacement heifers, and row crops. Over the past 10 years, the Derr's have made great efforts to protect and preserve the natural resources on their dairy farm. In doing so, they have shared the benefits of conservation efforts with other farmers and the public. Fencing, a watering trough, and a roofed heavy use area protect a stream and increase options and opportunities to maximize grazing while maintaining healthy, productive pastures. To protect the soil in the win-



ter months, the Derr family plants cover crops. Liquid and solid manure storage facilities help to effectively manage manure nutrients to the benefit of crops and the environment. The Derr's commitment to conservation serves not only the farm, but the Middletown Valley, Catoctin watershed, and all of their downstream neighbors.
